

WINCHESTER MUNICIPAL UTILITIES APPLICATION FOR SEPTAGE TRUCK DISCHARGE PERMIT

In accordance with Winchester Municipal Utilities Policy number 205.2, all septage haulers are required to complete one application per truck they wish to be permitted to discharge at the Strodes Creek Wastewater Treatment Plant. Failure to accurately complete all sections of this application may result in refusal to issue a permit to the septage hauler.

Waste haulers must carry liability insurance, and a copy of their certificate of insurance must be submitted with this application. Such insurance shall afford bodily injury limits or liability for each person injured of \$1,000,000 for each occurrence.

SECTION 4: APPLICATION DUE DATE

In accordance with the requirements of Article 5, Section 14-176, "Permit Duration" of Ordinance 29-88, an application to renew this application must be filed a minimum of 90 days prior to the expiration date of the current permit. The permittee shall not discharge after the date of expiration. Septic hauler permits expire annually on June 30th.

SECTION 5: CERTIFICATION STATEMENT AND SIGNATURE

This application must be signed by an authorized representative for the business, after adequate completion of this form and review by the person signing below, who assumes all responsibilities.

"I have viewed and accepted all information submitted in this application to be true, accurate and complete. I consent to accept and to abide by all applicable ordinances, rules and regulations of the City of Winchester, Kentucky. I understand that falsification of any information submitted shall be cause for rejection of this application or termination of the septage hauler permit. I acknowledge that no hazardous waste or other incompatible wastes are to be transported or mixed with liquid waste hauled under this permit, and agree to provide accurate and complete manifests for all waste hauled to the WMU POTW. Any person violating the applicable ordinance or permit conditions may be subject to: fines, invoices for cost of repairs and cleanup due to illicit discharges, notice of violations, legal actions, and revocation of the permit. I understand that the permit is valid for one year and must be renewed on an annual basis to maintain a valid permit."
